During the meeting, Assabet Valley Affordable Housing, Inc. adopted new By-Laws that give the Hudson Housing Authority Board of Commissioners the responsibility of annually electing the directors of the AVAH board of directors. Upon a motion by Sarah Cressy, duly seconded by Christine Dimare, the Board voted UNANIMOUSLY 5-0 to adopt the Assabet Valley Affordable Housing, Inc. By-Laws, as applicable to the Hudson Housing Authority.

Upon a motion by Sarah Cressy, duly seconded by Christine Monteiro, the Board voted UNANIMOUSLY 5-0 to appoint the following slate of directors to the Assabet Valley Affordable Housing, Inc. Board of Directors, effective immediately:

The Board reviewed an Administrative Services Agreement between HHA and AVAH for HHA to provide administrative services and day-to-day management of AVAH. The contract provides a \$100 per month stipend paid to HHA for HHA's services. Upon a motion by Sarah Cressy, duly seconded by Cynthia Janeiro-Ehlke, the Board voted UNANIMOUSLY 5-0 to enter into an Administrative Services Agreement with Assabet Valley Affordable Housing, Inc, as presented. Jaclyn Beaulieu will act as contract officer on behalf of HHA.

The Board reviewed a Management Agreement between HHA and AVAH for HHA to act as managing agent for property owned by AVAH, including the two rental condominiums. The Agreement provides 6% of gross revenues collected on behalf of the managed property to be paid by AVAH to HHA. Upon

a motion by Sarah Cressy, duly seconded by Christine Dimare, the Board voted UNANIMOUSLY 5-0 to enter into a Management Services Agreement with Assabet Valley Affordable Housing, Inc, as presented. Jaclyn Beaulieu will act as contract officer on behalf of HHA.

Upon a motion by Sarah Cressy, duly seconded by Christine Dimare, the Board voted UNANIMOUSLY 5-0 to adjourn at 6:18 p.m.
